BONENKAI



December is the busiest month of the year in Japan. People aren't busy shopping for Christmas — they're partying.

Bonenkai (literally: "forget the year party") are the most important parties of the year.

As the name implies, the purpose of *bonenkai* is to forget the troubles of the past year and look forward to success in the next.

Every company in Japan holds at least one *bonenkai*. In many cases, *bonenkai* happen at the company, team and department level.

Bōnenkai are seen as times for *bureikoh* or letting one's hair down and not worrying about the boss/employee formal relationship or the rank and age divisions.

Bonenkai first appears in a document from the 15th century which refers to several yearend convivial gatherings among samurai called *Toshi wasure* or literally "forget the year" parties.

The most popular tradition of a Shinto wedding is the exchange of nuptial cups, called *Sankon no Gi* or *San san kudo*. *San* means 3 and *ku* means 9. So, *san san kudo* means three, three, and nine. The groom and bride drink sake three times each, from three different-sized cups called *sakazuki*. In their exchanging of cups, they are symbolically exchanging their marriage vows.

towards a new stone monument to be erected in honor of shrine members who persisted against overwhelming odds in a lawsuit

Seizo Imamura of Osaka in front of the paddle acknowledging his contributions towards the stone monument

filed in 1949 against discrimination by the Federal Government.

The lawsuit by Kotohira Jinsha was the first ever initiated by a Japanese organization in the history of the United States, paving the way for similar lawsuits by other Japanese organizations.

The present stone monument erected in 1965 is suffering from crumbly disintegration as a result of fine particle and soot pollution from H-1 freeway.

The stone monument is meant to serve as a constant reminder of the hardships and indignities suffered at the hands of a nation misguided by wartime hysteria, racial prejudice and fear, which we must not allow to happen again to any group, regardless of race, religion or national origin.
